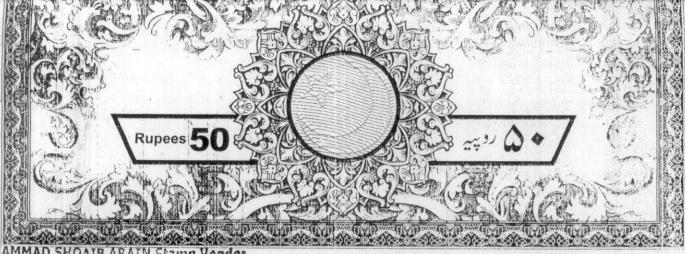

The Procuring agency hereby covenants to pay the contractor, in consideration of the execution and completion of the works as per provisions of the contract, the Contract Price or such other sum as may become payable under the provisions of the contract at the times and in manner prescribed by the contract.
